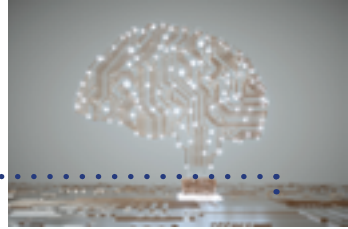

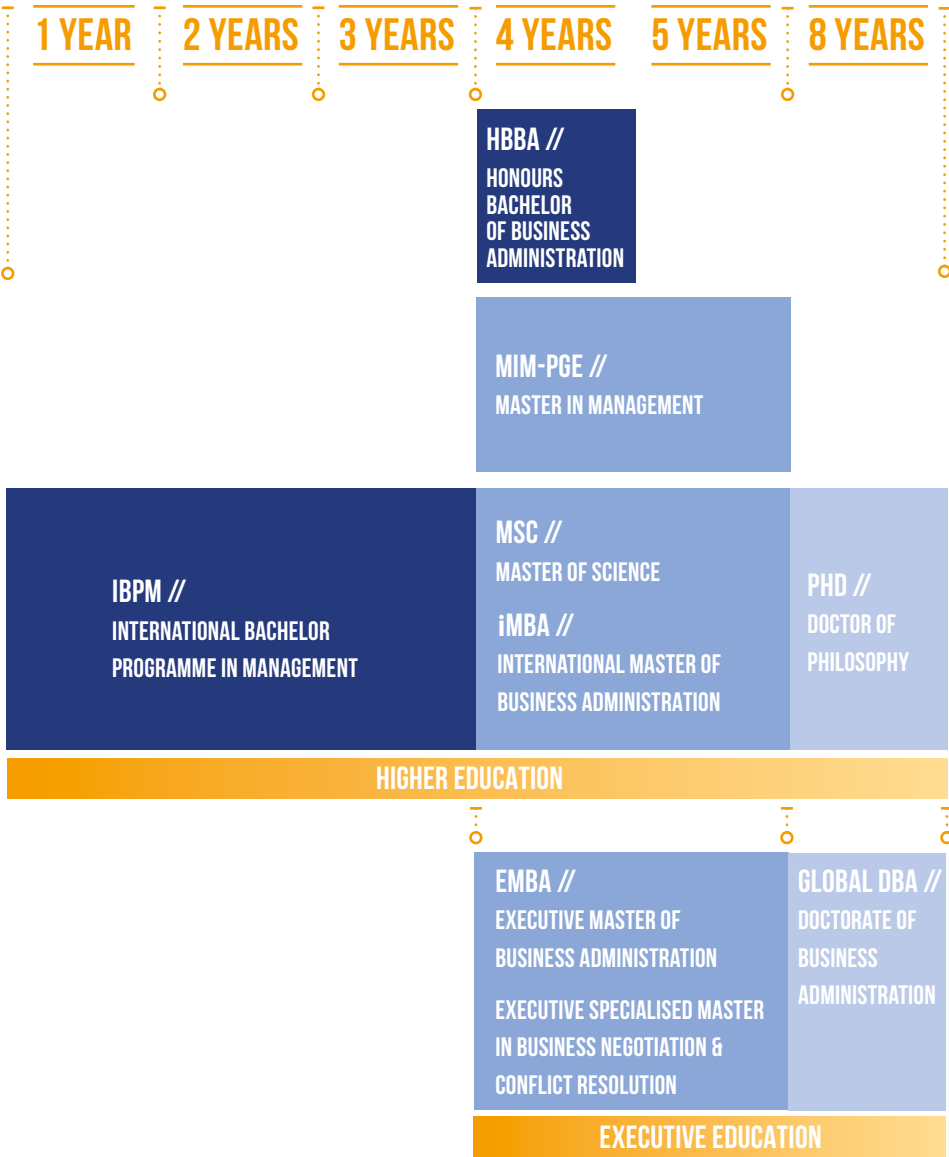

A 3-year Bachelor programme which enables students to develop key managerial skills through active experiential learning.

>>> Entrance level: High School Diploma or equivalent, Possible entry in 2<sup>nd</sup> and 3<sup>rd</sup> year after 1 or 2 years of undergraduate study.



## HONOURS BACHELOR IN BUSINESS ADMINISTRATION

Business!

#### **Online Intensive English Course**

This programme offers an alternative way to improve student's English communication skills with exclusive business-relevant content and Individual training guidance with a pedagogical consultant.

Students will have 6 month unlimited access to the E-learning content platform as well as virtual classes, 10 individual telephone classes and the preparation for the TOEIC test.

## CERTIFICATE IN BUSINESS GAMIFICATION: MANAGING AND MONITORING PROJECTS IN EXTENDED REALITY

Students complete two online modules licensed by UBISOFT, a worldwide leader in the video gaming industry. The completion of online modules will be guided by specific training from Artefacto, a leading company specialised in virtual and augmented reality applications.

### INTERNATIONAL BUSINESS PROFICIENCY CERTIFICATE (iBPC)

The French social security system is mandatory, but free of charge for any Rennes School of Business student. For medical cover during the first three months, the school strongly advises students to take out a private social security insurance contract in their home country.





# WELCOME SERVICES

## THE WELCOME OFFICE //

supports students with accommodation and administrative procedures (Housing allowance, health care registration...)

The welcome office facilitates the obtention of a resident permit through a privileged partnership with the French immigration administrative office (préfecture)

## WELL'COME ASSOCIATION //

(the international student association) helps international students settle into the school and life in Rennes. Not only does it pick them up at the station or airport on their arrival, it also organises tourist trips (Mont St. Michel, Paris, etc.) and sports events.

## ALOHA CHECK IN //

The school organises an Aloha check-in for all international students upon their arrival. Students will have the opportunity to finalise their administrative enrolment and find a wide range of services in one place: healthcare, residence permits, banking, internet providers, mobile phones, bus passes, etc.

## WELCOME EVENTS //

Campus Game, to discover the school, the staff, the faculty and facilities. Campus Festival, to meet the Rennes School of Business community through music and sports events.

## STUDENT ADVISORY BOARD

The Student Advisory Board is a team of twelve students (including 3 Bachelor's students, 3 Masters of Science in Management and 6 MSc students).

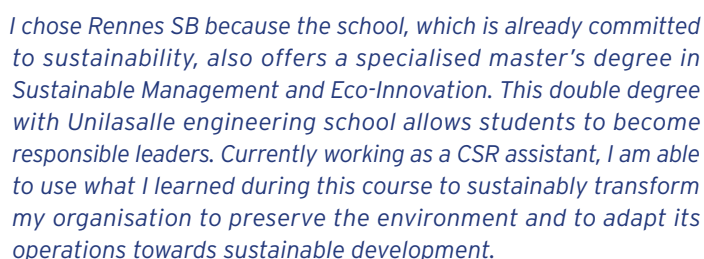

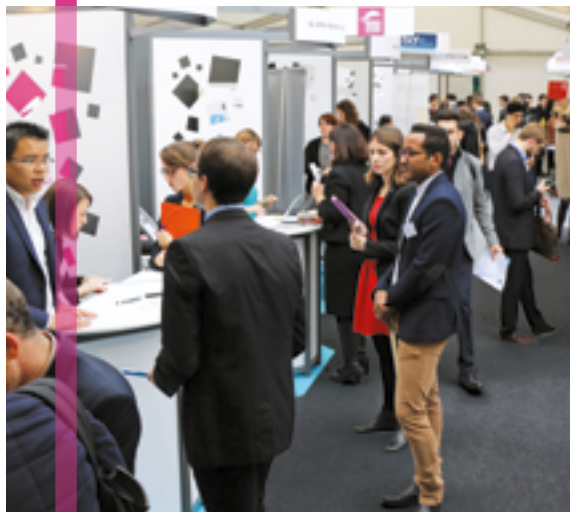

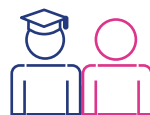


## JOB DATING
