- 一、依國立中正大學校長遊選委員會(下稱本會)第一次會議決議,公開徵求推薦 本校第六任校長候選人,預計自民國一一三年二月一日起聘,任期四年。
- 二、本校校長候選人之資格,應符合下列規定:
 - (一)候選人應符合教育人員任用條例第十條規定,具下列第一款各目資格之 一及第二款資格:
 - 1、具下列資格之一:
 - (1)中央研究院院士。
 - (2)教授。
 - (3)曾任相當教授之教學、學術研究工作。
 - 2、曾任學校、政府機關(構)或其他公民營事業機構之主管職務合計三年以上。
 - (二)候選人於一一三年二月一日尚未滿六十五歲。(參見教育人員任用條例 第三十三條)
- 三、本校校長候選人除應具教育人員任用條例及相關法令規定之校長資格及有 參選意願,且未有任用限制之情事外,應具有下列條件:
 - (一)秉持本校創校宗旨,並願落實本校教育理念。
 - (二)具崇高之教育理想及卓越之行政能力。
 - (三)具學術成就與聲望。
 - (四)對學術自由高度尊重。
 - (五)具有爭取及妥善運用相關資源之能力。
 - (六)處事公正且能超越政治、宗教、黨派及營利單位等利益。
- 四、經本會通過,並奉教育部核定之本校校長,應由本校聘任為專任教授,不得借調或合聘。
- 五、本校校長候選人推薦方式如下:
 - (一)本會委員推薦。
 - (二)本校校內專任助理教授十人以上連署推薦。
 - (三)國內、外學術單位之教授(研究員)或副教授(副研究員)五人以上連署推薦。
 - (四)校外學術團體推薦。
 - (五)本校校友會推薦。
 - (六)候選人自我推薦。

- (七)連署人應親自簽名。
- (八)校長候選人連署推薦表請註明連署代表人,且被推薦人不得參與連署。(九)本會委員不得以個人名義參與任何連署活動。

六、候選人應檢附以下表件:

- (一)校長候選人資料表
- (二)校長候選人連署推薦表(或校長候選人推薦表(本校校友總會、學術團 體推薦用))
- (三)校長候選人自我檢核表
- (四)蒐集個人資料告知事項暨個人資料提供同意書

National Chung Cheng University Searches for a New President

The Presidential Search Committee of the National Chung Cheng University (CCU) invites applications and nominations of candidates in its search for the university's sixth president. Beginning on February 1, 2024, the new president is anticipated to hold office for a term of four years.

The following criteria should be met by applicants for the position of President of the National Chung Cheng University:

- I. Presidential candidates should abide by the Act Governing the Appointment of Educators and meet the requirements stipulated in related laws and regulations.
 - A. According to Article 10 of the Act Governing the Appointment of Educators, candidates should meet any one of the requirements in item 1 and item 2 below:
 - 1. Eligibility (meet any of the following qualifications):
 - (1) Academician at Academia Sinica
 - (2) Professor
 - (3) Prior teaching and academic research experience equivalent to that required of a professor
 - 2. At least three years of experience, accumulated, as a director in schools, government agencies, or other state-owned or private business entities
 - B. Presidential candidates should not reach the retirement age of 65, as of February 1, 2024. (See Article 33 of the Act Governing the Appointment of Educators.)
- II. Apart from meeting the requirements of the Act Governing the Appointment of Educators, presidential candidates should comply with the following requirements:
 - Upholding the founding goal of CCU and being willing to put CCU's educational philosophies into practice
 - Having noble educational ideals and outstanding administrative skills
 - Having a solid reputation and academic achievements
 - Respecting academic freedom to the fullest extent
 - Possessing the capacity to obtain and make appropriate use of relevant resources
 - Being impartial and independent of all political groups and parties, religions, and forprofit businesses
- III. The presidential candidate approved by the committee and the Ministry of Education shall be appointed by the university as a full-time professor and not be temporarily transferred or jointly appointed.
- IV. Presidential candidates shall be nominated in any of the following ways:
 - Through nomination submitted by members of the CCU Presidential Search Committee
 - Through nomination jointly signed by at least 10 full-time assistant professors of CCU
 - Through nomination jointly signed by at least 5 professors/research fellows or associate professors/research fellows from academic institutions in Taiwan and abroad

- Through nomination submitted by an external academic institution
- Through nomination proposed by the CCU Alumni Association
- Through nomination submitted by presidential candidates themselves
- V. Joint nominators should comply with the following principles to nominate a candidate:
 - Nominators should sign the joint nomination in person
 - In the application form for presidential candidates, joint nominators must designate the representative nominator.
 - Nominees should not participate in the joint nomination process.
 - Members of the CCU Presidential Search Committee should not participate in any joint nomination in an individual's name.

Presidential candidates should provide the following documents to the committee:

- Presidential Candidate Nominee Information Form
- Presidential Candidate Joint Nomination Form or Presidential Candidate Nomination Form (For the CCU Alumni Association and academic institutions)
- Presidential Candidate Nominee Self-Checklist
- Notification and Letter of Consent for Collection, Processing, and Use of Personal Information

For those who would like to nominate a candidate, please fill out all the required forms and deliver them with relevant documents (in digital format) to the Presidential Search Committee of CCU by postal delivery (receipt as proof), e-mail, or in-person before 5 p.m. on June 12, 2023. No submissions will be accepted after the deadline. Please send the complete version of the required documents within 14 days if they are found to be incomplete.

The nomination forms can be downloaded from the "Presidential Search" section of the CCU Personnel Office website or obtained from the CCU Presidential Search Committee via phone call to the committee.
